In view of ‘Special Drive’ launched by the Election Commission of India for improvement of health of the Electoral Roll and enrollment of left out voters during Special Summary Revision, by collection of information by the Booth Level Officers through house to house visits from 15 November, 2017 which will continue till 30st November, 2017 for enrollment of every eligible citizens.

All stakeholders such as political parties, NGOs, village authority, town/ward authority and general voters are requested to extend utmost co-operation to the District Election Authority and the Election Department, J&K in their endeavor to improve the fidelity of electoral rolls.

Any person who thus becomes eligible for **inclusion** as a voter on 01-01-2018 as the qualifying date or any existing voter whose name or other particulars may not have been correctly incorporated in the Electoral Roll can apply for such inclusion in the Electoral Roll along-with two coloured passport size photographs or for necessary **correction**, as the case may be, before the Electoral Registration Officers (**Sub Divisional Magistrate, Kangan / Assistant Commissioner, Revenue, Ganderbal**), Assistant Electoral Registration Officers (**Tehsildar, Kangan / Gund / Ganderbal /Tulmullah/ Wakura / Lar**) and the Booth Level Officer (BLO) of the relevant Polling Station of two Assembly Constituencies of District Ganderbal.

For assistance of the general public, in connection with the **Special Drive to enroll left out electors**, the BLOs will be required to make the public aware about their house to house visit / (BLOs) locations and make yourself available at their Polling Station and to take all care and caution to update the Electoral Roll and make them error-free.
