Minutes of the meeting held under the Chairmanship of Addl. Deputy Commissioner, Ganderbal on 21-04-2018 regarding fixation of rates for Labourers/ Pack Pony/ Riding/Dandies and tentage accommodation for Shri Amarnathji Yatra 2018.

A meeting of the Rate Fixation Committee constituted for the fixation of rates of different services like tentage accommodation, Labourers, Pack Pony, Riding/Dandies for the upcoming Shri Amarnathji Yatra 2018 was held under the Chairmanship of Addl. The representatives of service providers demanded a minimum hike of 25% on the rates fixed for the year 2017 which was not accepted by the Chair and the Committee members as well. After thorough deliberations and taking the arguments of the representatives of service providers in consideration, the following rates were fixed for various services to be provided during Shri Amarnathji Yatra 2018.-




Moreover, the rates of the tentage accommodation shall be applicable to tents with the specifications conveyed by SASB.




