### NOTICE INVITING APPLICATIONS FOR PITCHING BOARDING-TENTS/SHOP-TENTS

### SHRI AMARNATHJI YATRA 2018

1. Applications on prescribed form (in duplicate) are invited from individuals/ Agencies for grant of permission to pitch boarding-tent/ shop-tents at various Yatra Camps along both the routes, i.e. Baltal and Pahalgam for Yatra 2018. The Application Forms shall be available from 15<sup>th</sup> February, 2018 to 15<sup>th</sup> March 2018 (till 4 pm) in the office of the Deputy Commissioner, Ganderbal in respect of Baltal-Holy Cave route.
2. The intending tent/shop owner would be required to submit, one Application Form indicating his preference to pitch boarding-tent/Shop-tent for various Camp locations in the Application Form, in case he intends to apply for more than one location.
3. The Shops/ Tents permission shall be granted by the Deputy Commissioners concerned. through draw of lots
4. The Shop/Tent permission holder will be require to pitch tents of the following specifications:  
Size
  - a) 12' x 14' for boarding tents
  - b) 8' x 12' for shop tents.Specifications
  - a) Double-Fly Untorn canvas or cotton tent.
  - b) Inner Fly -100% waterproof canvas or cotton at least 500 GSM with lining.
  - c) Outer Fly -100% waterproof canvas or cotton.
  - d) Canvas or Cotton should be rat proof and fire retar Jant.
  - e) With ground sheel, complete with metal/wooden poles and pegs.
  - f) Weather hoods on both sides for protection against rain/snow.
5. No individual/family shall be issued permission to pitch more than one tent in the Yatra area.
6. **Only one person (permission holder) who will be issued identity card shall be allowed to enter the Yatra area for managing the tent.**
7. The filled-in applications, alongwith documents (detailed in application form) shall be submitted at the following locations on the scheduled date and times as follows:-  
Office of Deputy Commissioner, Ganderbal; From 01-03-2018 to 31-03-2018 (till 4 pm) (Baltal-Holy Cave route)
8. No application form shall be entertained after the prescribed date.
9. Permission will be issued subject to the agreement to abide by the prescribed terms and conditions.
